## 1. SALES & COMMISSION

All payments will be made via check unless otherwise specified.

### **3. LIABILITY & INSURANCE**

Studio 42 and associated venues will take reasonable care in handling artwork. However, Studio 42 is not liable for any loss, theft, or damage during transport, installation, display, or removal.

Artists are strongly encouraged to carry their own insurance.

### **4. ARTWORK HANDLING, DELIVERY & PICKUP**

The Artist agrees to deliver all artwork in a professional, display-ready condition. This includes proper wiring, framing (if applicable), and secure packaging suitable for safe handling and transport.

The Artist is responsible for:

- Ensuring the artwork is structurally sound and ready for exhibition
- Transporting the artwork to and from the event
- Removing all artwork promptly following the conclusion of the event unless otherwise arranged

Studio 42 is not responsible for any damage resulting from improper packaging or presentation by the Artist.

Specific delivery and pickup instructions will be communicated separately prior to each event.

---

### **5. ABANDONMENT POLICY**

Any artwork not retrieved within 14 days following the event, without prior written arrangement, may be considered abandoned.

In such cases, Studio 42 reserves the right, at its sole discretion, to:

- Take ownership of the artwork
  - Sell, donate, or otherwise dispose of the artwork
  - Retain any proceeds resulting from the sale of abandoned work

## **6. PROMOTIONAL RIGHTS**

The Artist grants Studio 42 the right to photograph, record, and use images or representations of the artwork for marketing, promotional, archival, and press purposes, with credit to the Artist whenever reasonably possible.

## **7. WARRANTIES**

The Artist represents and warrants that:

- They are the sole creator and rightful owner of the submitted artwork
  - The work does not infringe on any copyrights, trademarks, or rights of third parties

## **8. ARTIST RESPONSIBILITIES**

The Artist agrees to:

- Provide work that is ready for display (properly wired, stable, and presentable)
  - Meet all deadlines related to submission, delivery, and communication
  - Conduct themselves professionally during the event
